Rules of Eligibility:

- 1) Entries not confined to Van Wert County.
- 2) Entrants must purchase an Individual Membership or Season ticket to exhibit at the Van Wert County Fair.
- 3) Entrants must fill out an entry form & entries must be registered at the Van Wert County Fair Board Office prior to the fair. Entries close August 11, 2018.
- 4) No Exhibitor will be allowed to make more than one (1) entry in any one class.
- 5) All baked goods shall be made from scratch.
- 6) Entry must be the WHOLE bread, cake, pie, or dessert, unless specified # of pieces.
- 7) Entry tags are to be placed with each article.
- 8) All baked goods except pies and cakes may be picked up 8:00am – 12 Noon on Wednesday August 30, 2017. Items left will be put out for sampling. Entries must be brought in Tuesday, August 29, 2017 from 8:00 AM - 12 Noon.
- 9) All pie and cake entries become the property of the Van Wert County Fair, to be sold at auction. The auction will be held on Wednesday, August 29, 2018 at 7:00 PM in the Administration Building.
- 10) Premiums may be collected at the Treasurer's Office, located at the east end of the Grandstand.
